# Finalized the transfer of 95% of ReValuta S.p.A. to CRIF

**7 March**, **2023** – Following the announcement to the market of May 30, 2022, Tinexta S.p.A., leading company in Digital Trust, Cybersecurity and Business Innovation, listed on the Euronext Star Milan segment ("**Tinexta**"), announces that today the transfer to CRIF S.p.A. of 95% of the share capital of ReValuta S.p.A. for a consideration of Euro 48.2 million has been finalized.

The equity value has been determined on the basis of an enterprise value for ReValuta of Euro 46.0 million, adjusted for estimated net debt at closing. Parties have agreed a revision of the enterprise value of Euro 4.0 million to account for the deterioration in macroeconomic conditions, occurred and progressively consolidated following the conclusion of original agreements.

Listed on the Europeaxt STAR Milan (MIC: MTAA), it is included in the European Tech Leader index as a high-growth tech company.
