The purchase transactions were carried out in compliance with applicable legislation and regulations, as well as consistent with and within the limits indicated by the shareholders authorization and the related Board implementation resolution.

During the period of implementation of the Program considered as a whole (from February 8th to March 8th, 2023), FinecoBank purchased a total of 31,000 treasury shares, equal to 0.00508% of share capital, at an average unit price of 16.75520 Euro, for a value of 519,411 Euro.

At the date of this press release, the Bank holds 91,459 treasury shares, equal to 0.01499% of share capital.
