**Milan, March 10, 2023** – In relation to the share buyback program approved by the shareholders’ meeting on May 5, 2022 that was started on February 22, 2023, as communicated to the market on the same date, Nexi S.p.A. (“**Nexi**”), on the basis of the information provided by Intermonte SIM S.p.A. (code: INTSITM1) as appointed intermediary, announces that it has purchased on Euronext Milan between March 3, 2023 and March 9, 2023 n. 167,561 Nexi ordinary shares (ISIN IT0005366767) for a total amount of Euro 1,301,884.38.
