**FINALIZED THE SALE OF THE PARTICIPATION IN LA LINEA S.p.A. AND ITS
CONTROLLED COMPANY MARTINI BUS S.r.l.**

Milan, 31 March 2023 – Following to the announcement made on 15 March 2023, FNM S.p.A. ("FNM") today finalized the sale of the participation held by FNM in La Linea S.p.A., which also resulted in the divestment of the ownership held indirectly in Martini Bus S.r.l. The transaction was settled once the obligations under the preliminary agreement signed on 7 December 2022 were fulfilled. As for the financial effects, the sale of the participation determines the exit of the two subsidiaries from FNM's consolidation perimeter from 16 January 2023. It should be recalled that as of 31 December 2022, the investment in La Linea was reclassified to assets held for sale, in accordance with IFRS 5.
