PRESS RELEASE

Friday, 7 April 2023 –Reference is made to the “*up to €70,000,000 Senior Secured Floating Rate Notes due 2029*” (ISIN code: IT0005495228) (the **Notes**) issued by Gnocchi Star S.p.A. (**Gnocchi**).

Notice is hereby given to the holders of the Notes that, as previously announced on 1 February 2023, Gnocchi has merged by incorporation into its wholly owned subsidiary, Il Pastaio S.r.l., with the simultaneous transformation of Il Pastaio S.r.l. into a joint-stock company (*società per azioni*) (the **Merger**). The resulting entity has been renamed “Il Pastaio S.p.A.” (**Il Pastaio**). The deed of merger was executed on 4 April 2023 and the Merger became effective on 6 April 2023, following the registration of the deed of merger with the Companies’ Register of Milano-Monza-Brianza-Lodi and with the Companies’ Register of Brescia.

Pursuant to the Merger, Il Pastaio has universally succeeded to, and assumed by operation of law, all of the obligations, rights, interests and liabilities of Gnocchi, including all of the obligations, rights, interests and liabilities of Gnocchi pursuant to, and in connection with, the Notes, which are admitted to trading and continue to be admitted to trading on the Vienna MTF managed by the Wiener Boerse.

Following the Merger, Gnocchi ceased to exist and the business, activities and operations of Gnocchi will be carried on by Il Pastaio.
