SHARE BUY BACK

Reggio Emilia, 4 May 2023 – Newlat Food S.p.A. (the “Company” or “Newlat Food”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 28 April 2022, revoke and – in the same time – again authorized by the Shareholder’s Meeting of 27 April 2023, in the period from 1 April to 30 April 2023, the Company (i) bought back a total of 80,368 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 5.49, for a total value of € 444,197.13, and (ii) sold a total of 1,750 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 5.36, for a total value of € 9,437.50.
