UniCredit: update on the execution of the share buy-back programme during the period from 29 May 2023 to 2 June 2023

Milan, 6 June 2023 – Within the UniCredit S.p.A. (the "**Company**" or "**UniCredit**") share buy-back programme communicated to the market on 3 April 2023 and initiated on the same date, as per the authorisation granted by the Shareholders' Meeting of the Company held on 31 March 2023 (the "**First Tranche of the Buy-Back Programme 2022**") – on the basis of the information received from BNP Paribas Exane as intermediary in charge of executing, in full independence (so-called "*riskless principal*" or "*matched principal*"), the First Tranche of the Buy-Back Programme 2022 – UniCredit informs, pursuant to art. 2, paragraph 3, of the Delegated Regulation (EU) 2016/1052, that it has carried out the transactions indicated below.
