PLANETEL AND VODAFONE ITALIA SIGN FRAMEWORK AGREEMENT FOR USE OF THE ULTRA-HIGH SPEED OPTIC FIBRE NETWORK

Initial works for connection of network nodes defined

Treviolo (Bergamo), 7 May 2023 – Planetel S.p.A., (“the Company” or “Planetel”), the parent company of the group of the same name operating nationwide in the telecommunications sector, listed on **Euronext Growth Milan**, the multilateral trading system organised and run by Borsa Italiana S.p.A., announces that it has signed a multi-annual framework agreement with Vodafone Italia granting the IRU (*Indefeasible Right of Use*) for some sections of the fibre optic network.

The initial works for connection of the Vodafone Italia 4G and 5G mobile network base stations in the provinces of Bergamo, Brescia and Verona in accordance with the framework contract have already been planned in detail. This will enable Vodafone to offer its mobile network customers a higher-capacity service with better latency.

The strategic agreement forms part of Planetel’s broader cooperation with the leading mobile and optic fibre network operators with a strong local presence for the use of infrastructure already in place on the ground, with a view to developing synergies in the use of networks and generating an even higher return on Planetel’s infrastructure investments and fully exploiting the strategic opportunities these partnerships bring.

Bruno Pianetti, Chairman and CEO of Planetel S.p.A. – *“We are delighted to start a major partnership for the use of our ultra high-speed fibre backbone with a top player like Vodafone Italia. The agreement follows on from those already entered into with other national operators, which our Company has provided with connections to cover their 5G radio base stations and FTTH access networks. We are very happy that this new agreement enables us to even further optimise the return on our infrastructure investments. Today Planetel is a listed company with a very different structure and consolidated, respected know-how, able to create value by means of telecommunications infrastructures, and we are enthusiastic about this renewed confidence on the part of the major operators, which will enable us to fulfil our commitment to supply our customers with a quality service.”*
