ASTM GROUP CONFIRMED IN FIRST PLACE AMONG NON-LISTED ITALIAN COMPANIES IN THE 2023 INTEGRATED GOVERNANCE INDEX

For the second consecutive year, ASTM is confirmed in the top position among unlisted Italian companies in EticaNews' ranking that measures the integration of ESG factors in corporate governance

Tortona, 14 June 2023. For the second consecutive year, **ASTM**, a world leader in the management of motorway networks and in the design and construction of large infrastructural works and technology applied to transport mobility, is positioned at the top among unlisted Italian companies for the full and knowledgeable integration of sustainability policies in business strategies. This is attested by the Integrated Governance Index (IGI), the only research project in Italy on ESG integration in corporate governance and management models, which is promoted by EticaNews.

The Integrated Governance Index is a quantitative index based on a questionnaire addressed to a sample of Italian companies, both listed and unlisted. The reference panel includes, in this edition, the top 100 listed companies in Italy, the companies that publish the Non-Financial Statement pursuant to Legislative Decree no. 254 of 30 December 2016, the top 50 unlisted Italian and industrial companies in the Mediobanca ranking, recording the direct involvement of around 400 Italian managers. The results of the Index and the research were presented today at the eighth edition of the ESG Business Conference, an opportunity for networking, indepth analysis and comparison for investors, professionals and stakeholders, called to participate in debates and round tables.

This important acknowledgment confirms the fundamental role that sustainability plays within the organization, both nationally and globally. It represents an impetus of growth, transformation and competitiveness that guides the business strategy in the medium to long term.

ASTM Group is a world leader in the management of motorway networks, design and construction of major infrastructure works (EPC - Engineering, Procurement and Construction) and technology applied to mobility. Present in 15 countries, with about 17,000 employees and collaborators, the Group operates according to a One Company business model that incorporates integrated competencies, covering the entire value chain of the infrastructure sector. In the area of concessions, the Group is the second largest operator in the world in the management of motorway infrastructure with a network of about 6,200 km, of which more than 1,400 km in Italy, 4,700 km in Brazil through the listed company EcoRodovias and 84 km in the United Kingdom through its subsidiary Road Link. ASTM Group reported the following results for 2022: Total Revenues: ≤ 3.4 billion, EBITDA: ≤ 1.3 billion and Net Income: ≤ 40 million.
