GENERALFINANCE AND BANCA CASSA DI RISPARMIO DI SAVIGLIANO SIGN AN AGREEMENT FOR THE RESALE OF TAX RECEIVABLES LINKED TO THE SUPERBONUS FOR A VALUE OF 10 MILLION EUROS
