## FILING OF THE COMMON DRAFT TERMS OF CROSS-BORDER MERGER BY ABSORPTION OF UNIPOLRE D.A.C. INTO UNIPOLSAI ASSICURAZIONI S.P.A.

UnipolSai Assicurazioni S.p.A.
