PLANETEL AND OPEN FIBRE CONTINUE THEIR OPTIC FIBRE PARTNERSHIP

Agreement to speed up the rollout of the ultra high-speed optic fibre network in the provinces of Monza Brianza/Bergamo/Brescia/Verona

Treviolo (Bergamo), 29 June 2023 – Planetel S.p.A., (“the Company” or “Planetel”), the parent company of the group of the same name operating nationwide in the telecommunications sector, listed on **Euronext Growth Milan**, the multilateral trading system organised and run by **Borsa Italiana S.p.A.**, announces that it has signed a new framework agreement with Open Fiber S.p.A. granting an IRU (Indefeasible Right of Use) over some sections of Planetel’s optic fibre network in order to support the development of Open Fiber’s plan for the installation of ultra high-speed optic fibre.

The agreement, for which Planetel has already received orders in the month of May alone, aims to enable Open Fiber to provide FTTH ultra high-speed optic fiber services in the zones covered and will relate to the provinces of Monza Brianza/Bergamo/Brescia/Verona.

The project will make infrastructure available to customers on the ground more quickly through the use of existing structures, enabling the rapid reduction of the digital divide and giving access to services that have now become a basic necessity, thus improving the lives of residents, who will be able to benefit from innovative services such as remote working and learning and online interaction with the public sector, with guaranteed access at a connection speed of up to 10 Gigabits per second.

This agreement forms part of Planetel’s broader cooperation with Open Fiber and leading optic fibre network operators with strong market local penetration for the use of infrastructure already in place on the ground, with a view to developing synergies in the use of networks, generating an even higher return on Planetel’s infrastructure investments and exploiting the strategic opportunities generated by this additional partnership and collaboration.

Bruno Pianetti, Chairman and CEO of Planetel S.p.A. – *“The agreement strengthens and consolidates our existing commercial relationship with Open Fiber for the use of our infrastructure on the ground and enables Planetel to maximise its investments for the installation of Backbone and Backhaul networks, also through the use of other licensed operators (OLO). The agreement confirms our strategic vision of a proprietary backbone serving not just Planetel but also other large operators which do not have full infrastructural coverage of the areas concerned.”*

Among the first Italian Internet Service Providers (ISP and WISP) to gradually develop its position in the telecommunication and system integration market, the company has been able to stand out on the territory as a single player offering integrated digital solutions, ASP / Cloud services and other IT solutions.
