Servizi Italia S.p.A. informs that, in the period between 26 June and 30 June 2023 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2023 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 3,204 ordinary shares (corresponding to 0.010% of the Company's share capital) at an average price of Euro 1.3330 per share, for a total of Euro 4,271.07.
