Servizi Italia S.p.A. informs that, in the period between 17 July and 21 July 2023 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2023 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 5,700 ordinary shares (corresponding to 0.018% of the Company's share capital) at an average price of Euro 1.2971 per share, for a total of Euro 7,393.49.
