WEEKLY PRESS RELEASE ON TREASURY SHARES BUYBACK PLAN

Cernusco Lombardone (LC), *July 24, 2023* - Technoprobe S.p.A., a leading company in the design and production of probe cards (the “**Company**” or “**Technoprobe**”) listed on Euronext Milan, declares the purchase on the Euronext Milan market, according to the Shareholders’ Meeting on June 22, 2023 approval, (already announced pursuant to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999), throughout July 17, 2023, to July 21, 2023, of n. 275,500 ordinary shares (equal to 0.0458% of the share capital), at a weighted average price of Euro 7.9759, at the countervalue of Euro 2,197,365.00.

Purchases were made through the intermediary Mediobanca – Banca di Credito Finanziario S.p.A.

Probe cards are hi-tech devices that are custommade for each chip and allow the function of chips to be tested during the manufacturing process. These technologically-advanced designs and solutions are essential for ensuring the proper functioning and reliability of devices that play a crucial role in industries such as Information Technology, 5G, Internet of Things, home automation, automotive, aerospace, etc. As a result, Technoprobe is a critical link in the supply chain for the manufacture of chips, which are at the heart of today's technological world.
