Servizi Italia S.p.A. informs that, in the period between 7 August and 11 August 2023 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2023 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 4,000 ordinary shares (corresponding to 0.013% of the Company's share capital) at an average price of Euro 1.3106 per share, for a total of Euro 5,242.50.
