Arezzo, September 1, 2023 – SECO S.p.A. (the "Company" or "SECO") announces the new composition of the subscribed and paid up share capital after the maturation in favor of the shareholder Olivetti S.p.A. of the increased voting rights (no. 2 votes for each ordinary share) after 24 months from the date of registration in the list for the allocation of increased voting rights for a total of 7,502,726 shares, registered on August 11, 2021, and for a total of 2,773,943 shares, registered on August 31, 2021, as provided for in Article 7 of the Company's by-laws.

The new composition of the voting rights related to the outstanding shares of SECO as of September 1, 2023 is shown below, compared with the previous composition.
