Servizi Italia S.p.A. informs that, in the period between 28 August and 1 September 2023 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2023 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 3,350 ordinary shares (corresponding to 0.011% of the Company's share capital) at an average price of Euro 1.2819 per share, for a total of Euro 4,294.52.
