Servizi Italia S.p.A. informs that, in the period between 11 September and 15 September 2023 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2023 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 5,447 ordinary shares (corresponding to 0.017% of the Company's share capital) at an average price of Euro 1.2785 per share, for a total of Euro 6,963.85.
