Servizi Italia S.p.A. informs that, in the period between 2 October and 6 October 2023 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2023 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 2,200 ordinary shares (corresponding to 0.007% of the Company's share capital) at an average price of Euro 1.1927 per share, for a total of Euro 2,623.94.
