CONCLUSION OF THE MID-TERM COMMUNICATION STABILISATION PERIOD

Naples - 23rd October 2023 – Edil San Felice S.p.A. Società Benefit ("the Company" or "Edil San Felice"), a leading integrated operator active in the maintenance of critical infrastructures in Italy, listed on the Euronext Growth Milan market – announces that today Alantra Capital Markets S.A.U., Italian Branch (hereinafter also referred to as "Alantra"), in its capacity as the entity appointed to carry out the stabilization activity with respect to the ordinary shares of Edil San Felice (ISIN:IT0005561441), has partially exercised the Greenshoe Option granted by *The Sight* S.r.I for no. 218.014 ordinary shares of the Company with respect to the maximum no. 395.257 ordinary shares of the Company subject to the Greenshoe Option, with the subsequent return to *The Sight* S.r.I. of an aggregate amount of 177,243 ordinary shares of the Company lent under the Over-Allotment Option. By the exercise of the Greenshoe Option, the stabilisation period shall end with immediate effect.

The purchase price of the ordinary shares subject to the Greenshoe Option is equal to Euro 2.53 per ordinary share - corresponding to the offer price established within the framework of the Placement - for a total counter-value of Euro 551,575.42 and the relevant payment is scheduled for 26 October 2023.

Following the partial exercise of the Greenshoe Option under the above terms, the Offer covered a total of 4,467,028 ordinary shares of Edil San Felice for a total countervalue of Euro 11,301,580.84 and Edil San Felice's free float on the market is equal to 23.21%.

Edil San Felice's share capital will therefore be represented by 19,249,014 ordinary shares, with no par value, held as follows:
