Since the start of the programme, WIIT has bought N. 287,657 ordinary shares (equal to 1.03% of the share capital equal to Eur 2,802,066.00), for a total value of EUR 4,556,141.19.

Following the purchases made so far, WIIT holds a total of N° 1,917,937 own shares, equal to approximately 6.84% of the share capital equal to Eur 2,802,066.00.

The purchases have been carried out pursuant to the provisions of Art. 144-bis of Consob Issuers Regulation no. 11971/99, on regulated markets in accordance with trading methods laid down in market rules, in order to not allow for the direct pairing of buying and selling bids.
