COMMUNICATION OF THE TOTAL AMOUNT OF THE VOTING RIGHTS

pursuant to art. 85-bis, par. 4-bis, of the Issuers' Regulation

Arezzo, November 2, 2023 – SECO S.p.A. (the "Company" or "SECO") announces the new composition of the subscribed and paid up share capital after the execution of the capital increase following the partial exercise of the stock option plan named "Stock Option Plan of SECO S.p.A." (the "Plan"), resolved by the extraordinary Shareholders' Meeting on March 1, 2021 and subsequently amended on April 27, 2022, with the issuance of 12,144 new ordinary shares of the Company, without nominal value, with the same rights of those outstanding at the date of issuance/assignment.

The certification pursuant to Article 2444 of the Italian Civil Code, relating to the amount of the share capital, was filed with the competent Company Register of Arezzo on November 1, 2023, together with the updated text of the Company's by-laws.

The new composition of the voting rights related to the outstanding shares of SECO as of November 2, 2023 is shown below, compared with the previous composition.
