(the “Company” or “Newlat Food”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 27 April 2023, in the period from 1 October to 31 October 2023, the Company (i) bought back a total of 55,740 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 5.96, for a total value of € 332,261.69, and (ii) sold a total of 200 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 5.95, for a total value of € 1,190.00.
