## ANNOUNCEMENT OF TOTAL AMOUNT OF VOTING RIGHTS

Bologna, 6 November 2023

Unipol Gruppo S.p.A. (“Unipol” or the “Company”) announces that on 1 October 2023 the voting rights were increased with respect to 24,000,000 ordinary shares in accordance with article 127-*quinqüies* of the Consolidated Law on Finance, the provisions of the articles of association and the Regulations on shares with increased voting rights implemented by the Company on 25 June 2020 and available on its web site under the *Investors/Shareholders/Shares with Increased Voting Rights* section.

In accordance with article 85-*bis*, paragraph 4-*bis* of the CONSOB Issuers’ Regulation, the table below shows the data relating to the shares in issue and the number of voting rights comprising the Unipol share capital.
