## WEEKLY COMMUNICATION REGARDING THE SHARE BUYBACK PROGRAM DURING THE PERIOD FROM NOVEMBER 6<sup>TH</sup>, 2023 TO NOVEMBER 10<sup>TH</sup>, 2023

**Cesena (Italy), November 14<sup>th</sup>, 2023** – Technogym S.p.A. (“**Technogym**” and/or the “**Company**”) announces to have purchased, during the period from November 6<sup>th</sup>, 2023 to November 10<sup>th</sup>, 2023 a total number of 249,474 shares at a weighted daily average price of Euro 7.73 for a total countervalue of Euro 1,929,704.39 under the buyback program communicated to the market on November 6<sup>th</sup>, 2023 and launched on the same date, following the authorization by the Ordinary Shareholders’ Meeting held on May 5<sup>th</sup>, 2023. The purchases were made through the independent authorized intermediary Equita SIM S.p.A..

Based on information provided by the independent authorized intermediary in charge of carrying out the buyback transactions as per this press release, a summary of the daily transactions is given below, in aggregate.
