S&P CONFIRMS "BB" RATING AND "STABLE" OUTLOOK

Rome, November 21st, 2023 – doValue S.p.A. ("doValue", the "Company") is pleased to communicate that S&P Global has confirmed its Issuer Credit Rating at "BB" with "Stable" outlook; the rating and outlook apply also to doValue's Senior Secured Notes listed on the Luxemburg Stock Exchange for outstanding amounts of €264 million (maturity August 2025) and €296 million (maturity July 2026).

According to S&P Global, the "Stable" outlook reflects the expectation that doValue's net leverage will remain below 3x on a company-reported basis, alongside continued solid FOCF.

The shares of doValue are listed on the STAR segment of Euronext Milan (EXM) and, in 2022, the Group reported Gross Revenues of €558 million and EBITDA excluding non-recurring items of €202 million.
