WEEKLY COMMUNICATION REGARDING THE SHARE BUYBACK PROGRAM DURING THE PERIOD FROM DECEMBER 4TH, 2023 TO DECEMBER 8TH, 2023

Cesena (Italy), December 12th, 2023 – Technogym S.p.A. (“**Technogym**” and/or the “**Company**”) announces the purchase – during the period from December 4th, 2023 to December 8th, 2023 – of a total number of 113,000 shares at a weighted daily average price of Euro 8.67, for a total countervalue of Euro 978,614.93 under the buyback program communicated to the market on November 6th, 2023 and launched on the same date, following the authorization by the Ordinary Shareholders’ Meeting held on May 5th, 2023. The purchases were made through the independent authorized intermediary Equita SIM S.p.A..

Based on information provided by the independent authorized intermediary in charge of carrying out the buyback transactions as per this press release, a summary of the daily transactions is given below, in aggregate.
