## UniCredit: update on the execution of the share buy-back programme during the period from 4 to 8 December 2023

Milan, 12 December 2023 – Within the UniCredit S.p.A. (the “Company” or “UniCredit”) share buy-back programme communicated to the market on 30 October 2023 and initiated on the same date, as per the authorisation granted by the Shareholders’ Meeting of the Company held on 27 October 2023 (the “**First Tranche of the Buy-Back Programme 2023**”) – on the basis of the information received from Goldman Sachs International as intermediary in charge of executing, in full independence (so-called “*riskless principal*” or “*matched principal*”), the First Tranche of the Buy-Back Programme 2023 – UniCredit informs, pursuant to art. 2, paragraph 3, of the Delegated Regulation (EU) 2016/1052, that it has carried out the transactions indicated below.

The chart below provides aggregate details of the daily purchases of UniCredit ordinary shares (ISIN IT0005239360), made from 4 to 8 December 2023.

As of 8 December 2023, since the launch of the First Tranche of the Buy-Back Programme 2023, UniCredit purchased no. 42,037,149 shares for a total consideration of Euro 1,022,580,349.95. As of the same date, following the cancellation of the treasury shares on 12 September 2023, UniCredit holds a total of no. 56,096,814 treasury shares equal to 3.14% of the share capital.
