## **MAPS GROUP WILL IMPLEMENT THE DIGITAL HEALTH SERVICES OUTLINED IN THE AGREEMENT BETWEEN THE ABRUZZO REGION AND THE NATIONAL STRATEGIC HUB**

### **The contract fee amounts to 3.6 million euros**

Parma, 22 December 2023

**MAPS** (MAPS:IM; IT0005364333), an Innovative SME listed on Euronext Growth Milan and active in the digital transformation sector, announces that it has been awarded, through its subsidiary Iasi s.r.l., the implementation and integration activities of the digital health services of the Abruzzo Region outlined in the agreement signed between the Region and the National Strategic Hub.

Among the various tasks, Maps Group will oversee the enhancement and maintenance of the Abruzzo Sanità Online platform, the portal for digital healthcare services, integrating the delivery of new services such as celiac assistance, medical device distribution, outpatient and inpatient waiting lists, vaccination, screenings, and pharmacies. Moreover, patients will have direct access to their medical reports through the portal. Within this initiative, Maps Group will act as a regional orchestrator, guaranteeing interoperability between the Regional Health Authorities (ASL) and the portal.

To further advance regional healthcare digitization, Maps Group will also undertake the digitization and dematerialization of the process for selecting and changing primary care physicians and optimize the regional registry by integrating it with the ANA national registry.

Finally, Maps Group will oversee the governance of the healthcare services waiting list and provide the region with Clinika, a product equipped with sophisticated artificial intelligence systems and semantic analysis of clinical text, capable of assessing the appropriateness of healthcare prescriptions.

The total fee amount to 3,634,000.00 euros plus VAT, regulated by 2 different contracts:

- A biennial contract, totaling 2,902,000.00 euros plus VAT, governing the implementation of certain healthcare services on the regional portal, the supply of Clinika, the dematerialization of primary care physician selection and revocation, and the integration of the regional registry with the National Registry.
- A three-year contract, totaling 732,000.00 euros plus VAT, governing the implementation of remaining services related to screenings and the vaccine registry on the regional portal.

**Marco Ciscato, Chairman of Maps Group**, comments: "We are thrilled to have been selected to lead the integration of digital health services in Abruzzo. This opportunity confirms our commitment to promoting innovation in the healthcare sector through advanced digital solutions. Collaboration with the Abruzzo region represents a significant step towards more efficient and accessible healthcare for citizens. We are ready to provide our expertise and technologies to optimize patient experience and support local healthcare facilities in delivering quality services."

Italia. Through its solutions, Maps Group enables customers to extract value from data in order to make better decisions and innovate their business models.

With the Maps Healthcare Business Unit, the Group covers the innovative trends of Patient Experience and Telehealth, as well as providing Diagnostic and Hospital Information Systems to public and private customers. The Maps Energy business unit supports the changes taking place for the energy transition, first and foremost those of flexibility and energy communities, as well as energy efficiency. In the field of sustainability, the Maps ESG Business Unit commercialises solutions that measure the achievement of corporate and employee goals, manage risks and report on non-financial performance. Lastly, through the Maps Lab Business Unit, the Group operates in an Open Innovation context, responding to large companies' specific needs through tailor-made products or solutions. The Group is also strongly committed to Research and Development activities. The Research & Solutions division is responsible for identifying market needs and evolving Maps' products.

The Group closes 2022 with consolidated revenue of Euro 24.7 million (+15% compared to 2021) - with revenue growth from Maps Healthcare (+26%) and a significant contribution from the newly founded Maps Energy - and EBITDA of Euro 5.9 million (EBITDA Margin 23.8%).

Over the past four years, Maps Group has quadrupled its revenues from products (EUR 20.2m in 2021, or 84% of consolidated revenues) and more than tripled its revenues from recurring fees (EUR 9.4m in 2022, or 39% of consolidated revenues), consolidating its business model based on high-margin, scalable products, replacing the previous business model based on non-scalable, tailor-made solutions. The Group's organic growth is accompanied by significant M&A activity. Over time, the Group has acquired: IG Consulting S.r.l. (2011), Artexe S.p.a. (2018), Royalty S.r.l. (2019), SCS Computers S.r.l. (2020), IASI S.r.l. (2021) I-TEL S.r.l. (2022) and Energenius S.r.l. (2022).
