# Early renewal of four-year contract with additional Cyber Security services for a total value of approximately Euro 6.4 million signed with an Italian multinational company

Milan, 27 December 2023 – WIIT S.p.A. ("WIIT" or the "Company"; ISIN IT0005440893; WIIT.MI), one of the leading European operators in the market of cloud computing services for enterprises, focused on the provision of continuous Hybrid and Private Cloud services for critical applications, has signed the early renewal of its four-year contract, extending the scope thereof with additional Cyber Security services, for a total value of approximately Euro 6.4 million, with a leading Italian multinational company (the "Client") active in the research, design, production and sale of creative expression tools.

The Client confirmed its trust in WIIT Private Cloud services, renewing the contract in advance of the natural expiration of the existing agreements, thus ensuring the continuity of existing activities and confirming the collaboration for the next 4 years.
