## WEEKLY COMMUNICATION REGARDING THE SHARE BUYBACK PROGRAM DURING THE PERIOD FROM JANUARY 15<sup>th</sup>, 2024 TO JANUARY 19<sup>th</sup>, 2024

**Cesena (Italy), January 23<sup>rd</sup>, 2024** – Technogym S.p.A. (“**Technogym**” and/or the “**Company**”) announces the purchase – during the period from January 15<sup>th</sup>, 2024 to January 19<sup>th</sup>, 2024 – of a total number of 63,000 shares at a weighted daily average price of Euro 8.89, for a total countervalue of Euro 559,086.90 under the buyback program communicated to the market on November 6<sup>th</sup>, 2023 and launched on the same date, following the authorization by the Ordinary Shareholders’ Meeting held on May 5<sup>th</sup>, 2023. The purchases were made through the independent authorized intermediary Equita SIM S.p.A..

Based on information provided by the independent authorized intermediary in charge of carrying out the buyback transactions as per this press release, a summary of the daily transactions is given below, in aggregate.
