SHARE BUY BACK

Reggio Emilia, 1 March 2024 – Newlat Food S.p.A. (the “Company” or “Newlat Food”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 27 April 2023, in the period from 1 February to 29 February 2024, the Company bought back a total of 99’326 ordinary shares on the Mercato Telematico Azionario (equal to 0.23% of the share capital) at an average share price of € 7.43 and for a total value of € 730’053.26.
