### CASA DI MODA BRUNELLO CUCINELLI: Update on the execution of the shares' buy-back programme

*Solomeo, March 22<sup>nd</sup> 2024* – Brunello Cucinelli S.p.A. (“**Brunello Cucinelli**” or the “**Company**”) announces to have purchased, in the period between March 18<sup>th</sup> and March 21<sup>st</sup> 2024, 47,250 ordinary treasury shares, equal to 0.0695% of the total 68,000,000 issued shares, for a total amount – fees excluded – of Euro 4,962,172.78, within the shares' buy-back programme (the “**Programme**”) resolved by the Shareholders' Meeting of April 27<sup>th</sup> 2023 (the “**2023 AGM**”) and under the start resolved by the Board of Directors on August 29<sup>th</sup> 2023 (the “**Start**”), already disclosed pursuant to EU Regulation n° 2016/1052.

Purchases were executed by the authorised intermediary Mediobanca S.p.A.

The aggregate of the daily buy-back transactions on Euronext Milan (EXM) managed by Borsa Italiana S.p.A. is reported below and attached the detail of such transactions executed in the aforementioned dates.
