- the Reports of the Board of Directors on items 1 and 2on the agenda of the aforesaid Shareholders' Meeting, respectively: (i) the approval of the financial statements at 31 December 2023, the proposal for the allocation of the result for the year and the consolidated non-financial statement prepared pursuant to the Italian Legislative Decree 254/2016 (NFS) and (ii) the Remuneration Policy and compensation paid;
- the proxy form pursuant to Article 135 *undecies* and the proxy form pursuant to Article 135 *novies*;
- information on the Company's share capital.

The abstract of the notice of call was published on April 4th, 2024 in the Italian newspaper "Corriere della Sera".
