Servizi Italia S.p.A. informs that, in the period between 1 April and 5 April 2024 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2023 (previously communicated as per Art. 144-*bis* of Consob regulation 11971/1999), n. 7,114 ordinary shares (corresponding to 0.022% of the Company's share capital) at an average price of Euro 1.6947 per share, for a total of Euro 12,056.41.
