Servizi Italia S.p.A. informs that, in the period between 8 April and 12 April 2024 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2023 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 4,018 ordinary shares (corresponding to 0.013% of the Company's share capital) at an average price of Euro 1.7326 per share, for a total of Euro 6,961.70.
