Reggio Emilia, 3 May 2024 – Newlat Food S.p.A. (the “Company” or “Newlat Food”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 27 April 2023, revoke and – in the same time – again authorized by the Shareholder’s Meeting of 29 April 2024, in the period from 1 April to 30 April 2024, the Company bought back a total of 18’313 ordinary shares on the Mercato Telematico Azionario (equal to 0.04% of the share capital) at an average share price of € 5.76 and for a total value of € 105’874.71.
