EDIL SAN FELICE OBTAINS A CONTRIBUTION OF OVER €5 MILLION FROM THE REGION TO FINANCE THE ACQUISITION OF THE NEW INDUSTRIAL SITE IN NOLA AND DEVELOP NEW GROWTH PROJECTS

On 1 December 2023, Edil San Felice finalised the acquisition of a new industrial site in Nola, adjacent to the company's headquarters, with the aim of increasing its production capacity.

This investment and the operational activities that will be developed in the new production unit will be 50% financed through a non-repayable regional contribution of over Eu5mn

Naples, 15 May 2024 - Edil San Felice S.p.A. Società Benefit ("the Company" or "Edil San Felice"), a leading operator in the field of critical infrastructure maintenance in Italy, listed on the Euronext Growth Milan market - has been the beneficiary a non-repayable regional contribution of more than EUR 5 million, obtained through the POR CAMPANIA FESR 2021-2027, PR CAMPANIA FESR 2021-2027 and POC Campania 2014-2020 calls for tenders.

The contribution relates to a programme of the Campania Region aimed at implementing European funds designed to increase the competitive capacity of enterprises, support the spread of innovation, and support the implementation of strategic, innovative and high-impact productive investment programmes in the region.

On a request for admission of a total investment project of €10,589,163.94, relating to the development of a new production unit adjacent to the company's current headquarters, the non-repayable grant awarded to Edil San Felice amounts to €5,294,581.97, in compliance with the provisions that envisage a maximum facilitation of 50% of the investment through regional funds.

The funds obtained will be used to finance the acquisition of the new industrial site in Nola, which was announced in December 2023 with the aim of increasing production capacity, expanding the activity of carpentry and road and airport signalling, where there is a progressive increase in demand.

Work on the development of the new industrial project, which is currently underway, will be completed according to the current work schedule, in early 2025.

Through this investment, Edil San Felice will continue to offer development to its territory, creating employment and increasing productivity and competitiveness, thus meeting the criteria for the allocation of funds.

The programme, in fact, is defined in close coherence with the framework of the main European and national strategies and aims at strengthening the regional socio-economic system, making it more resilient, with the intention of reducing economic, social, gender, generational and territorial





inequalities. Indeed, one of the primary objectives of the funding is to strengthen the sustainable growth and competitiveness of the region's SMEs, supporting job creation.

The contribution represents an important recognition of the company's commitment to increasing its competitiveness through productive investments, while supporting the training of workers.

"We are very pleased to have received this important award," commented **Lorenzo Di Palma**, CEO of Edil San Felice. Edil San Felice has always placed the well-being of our territory and our community at the centre of its strategic action. Through the new industrial site, we will be able to further increase our production capacity, offering further development and employment, as witnessed by the important recruitment plan that we have been carrying out in recent months".
