NEW CONTRACT FOR EXTRAORDINARY MAINTENANCE OF TUNNELS AND VIADUCTS ON THE A56 FOR OVER 8 MILLION EURO

Naples, 05 June 2024 - Edil San Felice S.p.A. Società Benefit ('the Company' or 'Edil San Felice'), a leading operator in the critical infrastructure maintenance sector in Italy, listed on the Euronext Growth Milan market, announces that it has been awarded a new contract by Amplia Infrastructures S.p.A, worth € 8,224,477.71, for the execution of seismic upgrading works and NTC 2018 ('Norme Tecniche per le Costruzioni 2018') of the Calata San Domenico viaduct located on the A56 section of Tangenziale di Napoli S.p.A..

The total duration of the contract is 23 months and work is scheduled to start this month. In addition to the above-mentioned amount, a bonus will be granted in proportion to the reduction of the construction time, up to a maximum of € 700,000.00 in the event that the delivery time is brought forward by 7 months.

The above-mentioned works include: the strengthening of the elements characterised by a lack of resilient capacity, the replacement of the existing supports and the preparation of the metal carpentry necessary to create seismic restraints with the consequent solidarisation of the slabs in correspondence of the Gerber saddles adjacent to the piers of the viaducts, as well as the sewing of the longitudinal joint between the embankments of the two carriageways.

For Edil San Felice, this contract represents a further step forward in the growth of the extraordinary maintenance business, with a high degree of specialisation, as well as the start of work for the Engineering and Construction Business Unit, headed by the newly appointed director Carmine Orsini.

'I am excited to start my journey as BUIR Director of Edil San Felice with this new contract for the extraordinary maintenance of Major Works - commented Carmine Orsini - Engineering and Construction Director of Edil San Felice - It is essential to ensure the efficient and safe maintenance of the critical infrastructures of the national territory and I believe that Edil San Felice has the technical and administrative skills to be able to face these new challenges.'
