Trezzo sull'Adda (MI), June 10, 2024 – Cofle S.p.A. (EGM:CFL) - a leading company in the design, production, and worldwide commercialization of control systems and control cables for the off-road vehicles, automotive, and automotive aftermarket sectors – announces, pursuant to Article 17 of the Euronext Growth Milan Issuers' Regulation, that it has terminated the Specialist contract with Banca Profilo S.p.A., which will hold this role until June 30, 2024.

The Specialist assignment, along with the Corporate Broker role, has been assigned to Websim (a division of Intermonte SIM) and will be effective from July 1, 2024.

Banca Profilo S.p.A. will continue to support the Company in the roles of Euronext Growth Advisor and Corporate Broker.
