EDIL SAN FELICE OBTAINS EURO 48 MILLION CONTRACT FROM RFI IN COOPERATION WITH MANELLI IMPRESA

For Edil San Felice, which will receive over 12 million euro out of a total of approx. 48 million, this is the first order in railway maintenance

Naples, 13 June 2024 - Edil San Felice S.p.A. Società Benefit ("the Company" or "Edil San Felice") - a leading integrated operator active in the maintenance of critical infrastructures in Italy, listed on the Euronext Growth Milan market - obtains a new important contract in the railway sector by RFI - Rete Ferroviaria Italiana. The contract was awarded in the context of a temporary consortium (RTI) with Manelli Impresa S.p.A., a leading player in the field of general construction.

Within the grouping, Edil San Felice's share will be Euro 12,194,941.37.

The contract, which will last four years, provides for the executive design and execution of extraordinary maintenance works inside 54 RFI stations in the regions of Piedmont, Liguria, Lombardy and Valle d'Aosta.

The aim of the works is to bring the railway buildings and their appurtenances up to standard, through various redevelopment works, plant upgrading and waterproofing, allowing for a restyling of the railway stations concerned that will guarantee a higher level of safety for passengers.

For Edil San Felice, this is a significant milestone in its path of growth and expansion also in adjacent sectors, as declared during the IPO. The contract in question, in fact, represents the company's first order in the railway maintenance sector, the main target segment for the horizontal expansion of its business.

"For Edil San Felice, this is a historic achievement,' commented Lorenzo Di Palma, CEO of Edil San Felice." Being able to obtain such a significant order in a sector that we have been looking at with great interest for some time is a source of pride for me, and it is proof that with passion, dedication and the right means, we can look very far ahead. Railway maintenance, both extraordinary and ordinary, is a market with a strong growth in demand, and one on which we are relying heavily for the continuation of our expansion path. We are convinced that, also by means of our recent internal reorganisation, we will be able to best meet all the challenges and opportunities of this segment.
