CHANGE TO THE FINANCIAL CALENDAR FOR 2024

Rome, June 14th, 2024 – In compliance with the existing regulations, doValue S.p.A. announces that the Board of Directors meeting scheduled to approve the Semi-annual report as of June 30th, 2024 has been postponed to August 7th, 2024 (compared to the date of August 1st, 2024 previously indicated).

The updated financial calendar is as follows:

- August 7th, 2024: Approval of the Semi-annual Report as of June 30th, 2024
- November 11th, 2024: Approval of the Interim Report as of September 30th, 2024

A conference call with investors and financial analysts will be held after each of the Board of Directors meetings scheduled for August and November. Any change to the above-mentioned dates will be timely communicated to the market.
