# TINEXTA, RECEIPT OF THE NOTICE FROM THE SELLING SHAREHOLDERS DEFENCE TECH CALL OPTION

Rome, 2 July 2024. Following what has been announced with the press release as at June 21, 2024, Tinexta S.p.A., a leader company in the Digital Trust, Cybersecurity e Business Innovation services, announces that on the date hereof – in relation to the call option concerning the participations owned by Comunimpresa S.r.l. and Ge.Da Europe S.r.l. (the "Selling Shareholders") in Defence Tech Holding S.p.A. Società Benefit – Tinexta Defence S.r.l. (the "Tinexta Vehicle") received from the Selling Shareholders a notice of disagreement concerning some items of the price of the call option exercise.

Pursuant to the option agreement, in the following 10 (ten) business days from the receipt of the aforementioned notice, the parties shall meet to attempt in good faith to reach an agreement. Should agreement not be found, it shall be necessary to proceed with the appointment of an independent expert.
