**EDIL SAN FELICE: ORDER WORTH OVER 13 MILLION FOR THE EXPANSION OF THE  
POLYTECHNIC OF MILAN IN THE BOVISA DROP AREA****The project is signed by Renzo Piano and the total amount is over 145 million euro.**

**Naples, 3 July 2024** - Edil San Felice S.p.A. Società Benefit ("the Company" or "Edil San Felice"), a leading integrated operator active in the maintenance of critical infrastructures in Italy, listed on the Euronext Growth Milan market - announces that it has been awarded, within a Temporary Grouping of Companies composed of S. A.C.S. S.r.l. (Group Parent) - EDIL SAN FELICE S.p.A. S.B. - OPERAZIONE S.r.l. - C.M.O. S.r.l., of a contract worth a total of EUR 145,100,000 from the Milan Polytechnic and the Municipality of Milan for the expansion of the University in the "Bovisa drop" area.

Edil San Felice's share is € 13,604,000.00 of which € 6,000,000.00 belongs to category OG3 (Roads) and € 7,604,000.00 belongs to category OG1 (Civil Buildings).

The works will consist of the construction of five buildings to house start-up offices, two buildings of the Milan City Council's civic schools, an area where a food court will be built, and 'the Corniche', i.e. the perimeter road in the 'Bosco della Goccia' area.

The start of the works is set for September 2024 and the total duration is four years.

This is a particularly significant order for Edil San Felice, which will contribute to the realisation of an important urban regeneration operation, with a high social and symbolic value for the city of Milan.

The participation in this operation, whose design is signed by Renzo Piano, is a further confirmation of Edil San Felice's growth and expansion path at national level.

**Lorenzo Di Palma, CEO of Edil San Felice**, commented: 'We are very pleased to be able to take part in such an important operation for the city of Milan, with important impacts at the social level thanks to the creation of spaces that will be used for the training and development of new entrepreneurial realities in our country. All this through the collaboration with the architect Renzo Piano, of whom we are honoured for what he represents in Italy. Moreover, as far as Edil San Felice is concerned, this order is an important step forward in the civil construction sector, confirming the differentiation of investments and activities that we are pursuing'.
