**Luxembourg, July 19, 2024.** - Tenaris S.A. (NYSE and Mexico: TS and EXM Italy: TEN) (“Tenaris”) announced today that pursuant to its Fourth Tranche of the Share Buyback Program announced on June 14, 2024, covering up to \$300 million to be executed in the open market, it has repurchased the following ordinary shares from July 15 to (and including) July 19, 2024:

From July 15, 2024 to (and including) July 19, 2024, the Company has purchased a total of 1,110,360 ordinary shares for a total consideration of €16,113,123, equivalent to USD17,573,844.

As of July 19, 2024, the Company held in treasury 51,503,977 ordinary shares (including 16,367,003 ordinary shares bought in the second tranche and 18,080,524 ordinary shares bought in the third tranche), equal to 4.43% of the total issued share capital.

Tenaris intends to cancel all shares purchased under the Program in due course.
