Notice of change of share capital

Filing of certificate pursuant to Article 2444 of the Italian Civil Code and updated company by-laws

August 1st, 2024

Expert.ai S.p.A. (the "**Company**" or "**Expert.ai**"), announces the new composition of the share capital fully subscribed and paid-in following the full subscription of the capital increase, for a total amount of Euro 29,667,518.10 (of which Euro 269,704.71 to be allocated to share capital and Euro 29,397,813.39 to be allocated to share premium) resolved by the Extraordinary Shareholders' Meeting on May 22 and whose terms and conditions were set by the Board of Directors on June 28, 2024 ("**Capital Increase**").

In the context of the Capital Increase, no. 26,970,471 new ordinary shares of Expert.ai (the "**New Shares**") have been issued, without nominal value and traded on Euronext Growth Milan, multilateral trading facility organized and managed by Borsa Italiana S.p.A.

In particular, the shareholder Sofia Holding S.r.l. had communicated to the Company that it has exceeded the significant threshold of 5%, while the shareholders Marco Varone (directly and through Laura S.S.) and Stefano Spaggiari (directly and through Palitone S.S.) have communicated a reduction in their shareholding below the 5% threshold.
