New five-year Euro 1.9 million contract for Secure Cloud services signed with intellectual property protection company

Milan, 05 August 2024 – WIIT S.p.A. ("WIIT" or the "Company"; ISIN IT0005440893; WIIT.MI), one of the main European players in the market of Cloud Computing services for businesses, focused on the provision of continuous Hybrid and Hosted Private Cloud services for applications critics, has signed a **new five-year contract worth approximately Euro 1.9 million, of which Euro 1 million allocated to new Premium Cloud services**. The agreement extends the existing contract with a major European company (the "Customer") specialising in intellectual property protection by extending the scope of services and adopting the Secure Cloud model.

The Customer has chosen WIIT, for the next five years, confirming the partnership already established over the years for Disaster Recovery services that, combined with SW-Based solutions for geographic networks, guarantee the protection of its data and processes for the sites in Italy and France. This renewed confidence highlights WIIT's ability to deliver highly specialised services and solutions with a high security profile, facilitating the customer's transition to a Secure Cloud model.

The new scope of the contract envisages the complete transformation of the service model, in which all of the Customer's most critical applications will be hosted by WIIT's European Data Centre network, in order to guarantee maximum resilience with the highest market level of security and certification. The multi-region coverage model at the Premium level will allow the management and hosting of systems requiring high reliability in the Premium North-West Italy zone, in the Milan metropolitan area, which will be joined by the Disaster Recovery service in the North-East Italy zone.

Starting from a hybrid model with DR (Disaster Recovery) services, the customer will move to a Secure Cloud model on two sites, where all critical systems will reside with attached SDWAN services and secure network connections to its sites.
