Servizi Italia S.p.A. informs that, in the period between 29 July and 2 August 2024 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 22 April 2024 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 6,000 ordinary shares (corresponding to 0.019% of the Company's share capital) at an average price of Euro 1.8688 per share, for a total of Euro 11,212.50.
