# PUBLICATION OF THE HALF-YEAR FINANCIAL REPORT AT 30 JUNE 2024

**Pero, August 7, 2024** – In accordance with current legislation, the half-year financial report at 30 June 2024, approved by the Board of Directors of F.I.L.A. - Fabbrica Italiana Lapis and Affini S.p.A. ("Fila") in the meeting of 6 August 2024, is available to the public, together with the report of the auditing company, at the registered office of Fila and on its website, section "Investors" (www.filagroup.it), as well as at the authorized storage mechanism "Emarket Storage" (www.emarketstorage.com).

**F.I.L.A.** (Fabbrica Italiana Lapis ed Affini), founded in Florence in 1920 and managed since 1956 by the Candela family, is a highly consolidated, dynamic and innovative Italian industrial enterprise and continues to grow market share. F.I.L.A. has been listed on EXM – Euronext STAR segment of the Italian Stock Exchange since November 2015. The company, with revenue of Euro 779.2 million in 2023, has grown significantly over the last twenty years and has achieved a series of strategic acquisitions, including the Italian Adica Pongo, the US Dixon Ticonderoga Company and Pacon Group, the German LYRA, the Mexican Lapiceria Mexicana, the English Daler-Rowney Lukas and the French Canson, founded by the Montgolfier family in 1557. F.I.L.A. is an icon of Italian creativity globally through its colouring, drawing, modelling, writing and painting tools, thanks to brands such as Giotto, Tratto, Das, Didò, Pongo, Lyra, Doms, Maimeri, Daler-Rowney, Canson, Princeton, Strathmore and Arches. Since its foundation, F.I.L.A. has chosen to focus on growth through continuous innovation, both in technological and product terms, in order to enable individuals to express their ideas and talent through tools of exceptional quality. In addition, F.I.L.A. and the Group companies work together with the Institutions to support educational and cultural projects which promote creativity and expression among individuals and make culture accessible to all. F.I.L.A. currently operates through 23 production facilities (of which two in Italy) and 32 subsidiaries across the globe and employs over 3,400.
